#### Navigation Circular No (1)/2024

#### أولاً:- بداية من ١ مايو ٢٠٢٤ سنتم تغيير أليه تقديم خدمات الرباط لتكون من محطات أرضية موزعه على طول القناة.

١- يتم تزويد خدمة الرباط فقط على ٣٠% من سفن القافلة طبقا للمعايير الأتيه :

- السفن ذات المسطح المعرض للهواء الأكبر ( windage area )
  - السفن ذات الحمولة الأكبر (GT)
  - السفن ذات الغاطس الأكبر ( DRAFT )
  - المسافات البينية للمفن ( لاتزيد عن سفيلتين )
  - سفن اخرى حسب ما تقررة هيئة قناة السويس

Starting from May 1<sup>a</sup> 2024, mooring service will be shore-based service, providing that the mooring boats will be distributed along the canal.

1-: Only 30% of the ships in the convoy will have the mooring service onboard.

SCA will decide which ships to have the onboard service based on the following criteria:

- · Ships with the largest wind-age area.
- Ships with the largest Gross Tonnage (GT).
- Ships with the largest Draft.
- Inter-ship distances not exceeding two ships.
- Others vessels as decided by SCA.

2- If one of the selected ships refuses or is unable to have the mooring service onboard, additional dues of USD 5,000 (five thousand USD) will be charged instead of imposing a tugboat as stipulated in Article 20, page 36 of the SC Rules of Navigation.

٢- يستثني من البند المذكور أعلاه السفن التالية نظراً لطبيعتها الخاصة

- أ- تصاحب المفن الحربي الأمريكي بقاطرة مفروضة لخدمة الرباط طبقا للبرتوكول الموقع مع الهيئة.
- ب تصاحب السفن الحربي جميع الجنسيات بقاطرة مفروضة لخدمة الرباط في حالة عدم القدرة على الرفع او رفض ربان السفينة بصعود عمال الرباط عليه
- ج الوحدات المقطورة والحفارات والوحدات المدمجة والوحدات ذات الطبيعة الخاصة سيتم خدمتهم بفلايك الرياط لسلامة الملاحة أو علي قاطرات مفروضة في حالة عدم قدرتها علي استقبال الخدمة علي السفينة طبقاً للأنحة الملاحة الحالية ديسمبر ٢٠٢٠

The following types of vessels shall be excluded from the above shore-based mooring service:

- a) U.S warships will be escorted by a mandatory tugboat for mooring service according to the protocol signed with SCA.
- b) Other Warships will be escorted by imposed tugboats if they refuse or unable to have the service onboard.
- c) Towed units, excavators, Rig, integrated units, and units of a special nature will have mooring service on board or escorted by imposed tugs if unable to have the service on board, as per current rules of navigation December 2020

#### ثانيا:- التعريفة الجديدة بتقديم خدمات الرباط والاتوار بالنظام الجديد كالاتى :-

- 1- سيتم تحميل كل سفينة عابرة بمبلغ إجمالي ثابت وقدرة ٢٥٠٠ دولار مقابل خدمات الرباط والانوار بالنظام الجديد ( سواء كانت الخدمة علي السفينة او من محطة أرضية ) مع إجراء تقييم مالى سنوباً في حاله ما تراءت الحاجة الي تغييرها ( ترتيبات خاصة للسفن )
- 2- في حالة طلب السفيئة التزود بخدمات الانوار (كشاف + كهربائي ) أو عدم مطابقة الكشاف للائحة الملاحة يزداد علي التعريفه السابقة بالبند (١) مقابل خدمات الأتوار ١٠٠٠ دولار ليصبح اجمالي المبلغ ٤٥٠٠ دولار تشمل خدمات الرباط و الانوار
- 3- في حالة عدم مطابقة التوصيلات الكهربائية للكشاف لمتطلبات الهيئة يتم توقيع الرسوم الأضافية المقررة وقدرها ٥٠٠٠ دولار بدءاً من العبور الثاني طبقا للائحة الملاحة ديسمبر ٢٠٢٠

Second: The new tariff for providing mooring and lighting services in the new system will be as follows:

- 1 any ship, whether having onboard or shore-based service will pay a fixed total amount of USD 3,500 for mooring and lighting services in the new system, with a financial assessment annually in case there is a need for amendments (as a special arrangement for ships).
- 2 In case the ship requests to be supplied with lighting service or if the searchlight does not comply with the SC Rules of navigation (searchlight + electrician), an additional USD 1,000 will added to the previous tariff in item (1) for lighting services, making the total amount USD 4,500, including mooring and lighting services.
- 3 If the electric connections don't comply with SC Rules of Navigation, the vessel will be charged with additional dues USD 5,000 from the second transit, as stipulated in SC Rules of Navigation, December 2020 edition.

Third : This circular shall be enforced from 1/5/2024.

في اطار التيسيرات التي تمتحها هيئة قداة السويس دعماً لعملائها قررت هيئة قداة السويس الأتي :-Regarding Circular No. (1/2024) concerning the mechanism of providing mooring services from ground stations distributed along the canal:

As part of the facilitations granted by the Suez Canal Authority in support of its clients, the Suez Canal Authority has decided the following:

المادة الاولى: تحدد تعرينة الرباط والانوار السنةن والرحدات ذات Article one: The tariff for mooring and lighting services for vessels and small marine units of less than 1500 tons is determined as follows:

1 - All transiting vessels will be charged a fixed total amount of \$2,500 for mooring and lighting services in under the new ground station system according to the conditions mentioned in Circular No. 1 of 2024.

Article three: This Circular shall be effective from of 1 April 2025

The mooring activity includes the process of binding and unbinding the ships crossing the Egyptian ports (PortSaid-Sues-Sharm Eleshikh-Nuweiba) Also the ships that bind in elbalah branch.
